Instructions for submission to Anjali

- Article submission format: All items must be neatly typed in MS Word (Arial or Times New Roman fonts; Font-size 12), spell-checked, and saved as “.doc” files. Please do not send pdf documents of your text files, as they are difficult to edit.
- Articles in Malayalam should preferably be typed in Malayalam fonts by downloading “Varamozhi” software (available at <http://varamozhi.wikia.com/wiki/Varamozhi>).
- If hand-written (best avoided), such articles should be sent as legibly written documents that have been scanned, and digitized.
- Any illustrations or photos that go with the article may be sent separately as high-resolution JPEG file attachments (or a suitable format that can be downloaded and printed). Please do not embed illustrations or photos directly into your articles. However, to indicate the preferred location of your pictures, you can send an additional pdf file of the illustrated article if necessary.
- Please include author’s full name, mailing address, phone number and e-mail address with the submission, and preferably a small passport size photograph (JPEG) with a short bio-data.
